You can pick the people you want to give you the services and supports you need. You can hire a staff member you already know, or you can ask CMH to help you find a qualified person. Using a special agreement, you can make your own contract with the person you choose. That is part of determining your own life - just like deciding where and with whom you want to live.

Self-Determination

“Self-determination” means that you can decide the services and supports you need *and* who provides them to you.

Self-determination is based on four ideas:

1. *Freedom*. You have the freedom to plan your life in terms of the services and supports you need.
2. *Authority*. You have the authority to take charge of an amount of public funds to buy those services.
3. *Support*. You have the right to resources and people around you to support you in the life you want.
4. *Responsibility*. You are responsible for taking part in your community and carefully using public funding.

Who can use self-determination?

You may take part in Self-determination if you use services from Community Mental Health (CMH).

Is self-determination required?

No. It is your choice. If you want, you can keep using your current CMH services.



How does it work ?

Using the cost of your services now, you will make your own budget.

You will make the budget as part of your Individual Plan of Service using the Person-Centered Planning process. Your family and friends can help you.

You will pick a “fiscal intermediary,” an expert in handling money, who is not part of CMH. She or he will help you hire and pay the qualified people who will give you services.
