I. CALL TO ORDER

The meeting was called to order at 3:30 p.m. by Chairperson Briggs.

II. ACTION: AGENDA CHANGES

III. CITIZENS WISHING TO ADDRESS THE BOARD

Ms. Angela Valdivia from Crossroads Recovery Community addressed the Board. She stated she had requested \$50,000 from Region 10 in June for Peer Recovery support at Crossroads and summarized the details of the request. Ms. Slingerland requested that she complete the new PA2 form and she will contact her on Wednesday to discuss her request.

V. FINANCE: PA2 REPORT

Mr. Carpenter presented a report showing FY2025 projected activity and FY2026 projections. The FY2026 balance is subject to change based on the finalized numbers for FY2025.

VI. ACTION: PA2 REQUEST FORM

Ms. Slingerland presented the draft PA2 Request form and reviewed each section of the form. It was discussed that, going forward, all PA2 requests will be requested using this form and will go directly to Ms. Slingerland. This Board requested to see all PA2 requests received by Region 10, whether they are rejected by Region 10 or recommended for consideration by the SUD Oversight Board. The PA2 Request form will be presented to the PIHP Board this month and will be posted on the Region 10 website by November 1st.

VII. CONTRACT MONITORING AGGREGATE REPORT

Presented by Ms. Slingerland. She reviewed the scores for the providers and noted that renewal of all contracts and continuation of delegated managed care functions was recommended.

VIII. DIRECTOR'S UPDATE

Ms. Slingerland stated all SUD provider contracts were sent out to providers the week of September 22nd. She also noted the SUDHH review with MDHHS took place at the end of September.
