A. FY2025 3rd Quarter Payment

Ms. Rottman provided an update on the timeline for closing out FY2025. She reported that the state has withheld 3rd quarter PA2 funds from PIHPs, as the funds will be used for debt services in the

state. It is not expected to be a recurring need. The FY26 projected budget will not be revised as PA2 revenue was a conservative projection and there is a reserve balance of \$7.7 million.

B. Action: FY2026 PA2 Request – St. Clair County I.M.P.A.C.T.

Discussion took place regarding the PA2 request. No action taken due to lack of quorum.

VI. DIRECTOR'S UPDATE

Ms. Slingerland reported that 242 plans of correction were issued during the contract monitoring process. Region 10 accepted 194 and 132 have already been resolved.

Meetings are taking place at the PIHP to discuss network adequacy and address goals on the Region 10 SUD Strategic Plan. FY2026 focus will be on adolescent services, including residential and outpatient services.

Ms. Slingerland noted that the new PA2 request form is now available on the website.

A transportation RFP will go to the PIHP Board this month for approval.
